Dear Mr. Tansey,

I understand you have invited President of Sri Lanka Mr Rajapakse to speak at Oxford Union tonight. Last year you invited British National Party (BNP) leader Nick Griffin and Holocaust denier David Irving. This year you invited Chris Langham who was jailed for down loading child pornography. I commend you for your consistency.

When you invited Chris Langham, BBC quoted you on 18 April 2008 in a report that you said "We do not invite speakers for publicity...We thought that he was a respected figure in his profession". I wonder, what might be your motive for your invite to Mr. Rajapakse.

Mr. Rajapakse's armed forces are responsible for killings of thousands of innocent civilians, torture, kidnappings and rape. Sri Lanka is the only country where the government forces kill civilians through indiscriminate aerial bombardment. It is like the British government bombing areas of Northern Ireland during the IRA struggle.

Lord Naseby is an ardent supporter of President Rajapakse. Once Lord Naseby was quoted as saying "I am a trained pilot myself and when you bomb from the air civilians do get killed" - Why don't you invite him as well?

It might be a bit of fun for you and your colleagues to invite fascists, racists and child molesters to your meetings but it is not so funny for the victims of holocaust, rape and torture. It is not so funny for people whose fathers, mothers, sisters, brothers, uncles and aunts have been kidnapped and killed.

President Rajapakse has blocked the only highway that connects the South and North of Sri Lanka thereby preventing distribution and supply of food, medical supplies and other essential goods to Tamil areas. This has resulted in hunger and starvation in those areas.

The country report on human rights released by the State Department, graced by Secretary of State Condoleezza Rice; the United States in its report on Sri Lanka totally condemned, criticised and, in fact, impeached its human rights record and the style of governance.
