Lies, Damn Lies and Ministerial Protestations

I am writing on behalf of the Tamil Writers Guild to state that it is with great sadness we read your reply at the Adjournment Debate held on 18th December 2008. In spite of all the information available to you, not least that provided by your fellow parliamentarians, you presented a picture of the Government of Sri Lanka's (GOSL) current and increasingly genocidal onslaught of the Tamil people (especially in northern Sri Lanka) in a way that was at best, another lost opportunity for the UK government to take a lead in denouncing those barbaric actions and at worst, a recipe for the Sri Lankan government to continue with those same inhumane practices.

I'd illustrate this with reference to the following examples from your speech:

1	LTTE is a ruthless terrorist organisation	At a time when major international politicians like Barack Obama and Hillary Clinton have differentiated between terrorists and national liberation/freedom fighters (and citing the Tamil Tigers specifically in the latter category), it really is disgraceful you cannot make a similar assessment. This is even more difficult to understand given the numerous global examples of 'terrorism' which have been subsequently deemed to have been political struggles for independence, with the USA, Israel, South Africa, Northern Ireland and Kosovo to name just a few of those instances.
2	LTTE has no democratic mandate to represent the Tamil population We must never allow a proscribed organisation to be the only voice of the people	Either you or your officials have not researched this conflict sufficiently or you have readily fallen for the GOSL's obfuscations. In 1976, all Tamil parties joined together and passed a resolution asking their Parliamentarians to seek the formation of a separate Tamil state in the homelands of the earlier Tamil Kingdoms. This was the Tamil people's mandate to their representatives. At the subsequent elections in 1977 and ever since, this mandate has been unchanged. The Thimpu Declaration adopted in Bhutan in 1985 by all Tamil groups specified the following 3 principles: a) Recognize Tamils as a nation. b) Recognize the concept of a Tamil homeland and c) Recognize the right to self-determination of the Tamils. These principles have been overwhelmingly

		supported by Tamils and most recently in the 2004 general election, the Tamil National Alliance (TNA), a grouping together of the majority of Tamil political parties, won overwhelmingly in 22 electorates in the north-east (TNA won 22 out of the 25 north-east seats). Their manifesto stated that the TNA accepts the 'LTTE's leadership as the national leadership of the Tamil Eelam Tamils and the Liberation Tigers as the sole and authentic representatives of the Tamil people'. Thus, the legitimacy of the LTTE lies in the Tamils' right to self-determination under international law and the long and continued support and recognition of the LTTE by the overwhelming majority of Tamils, both within and outside that wretched island.

It has dropped over 14 million kilogrammes of explosive (more than the power of the Hiroshima bomb) on Tamil areas, including Russian made OFAB-500 cluster bombs used against displaced persons camps. Last September, evidenced its use of FAEs (Fuel Air Explosives) containing Ethylene Oxide, which consumes oxygen in the atmosphere around the point of impact and sucks the gas out of the lungs of people within range and suffocating them sometimes to death. The US forces in Vietnam had been severely condemned for using the weapon, which is banned under the UN Convention on Genocide. Its use in the more recent onslaught against the Tamil homelands is the clearest demonstration of the Sinhalese regime's genocidal intent.

The incarceration of the Jaffna Tamils in what has been described as an open prison and the following quote from Brad Adams, Asia director at Human Rights Watch provides yet another authoritative and damning account: "The Sri Lankan government says that the 'liberated' East is an example of democracy in action and a model for areas recaptured from the LTTE, but killings and abductions are rife, and there is total impunity for horrific abuses."

With the current political climate framed by the war against terrorism, maybe it is timely for the international community to review its assessment of
the LTTE as a terrorist group, as it would seem clear that it is resorting to the right to self-defence while struggling for the right to self-determination. The international community needs to take a balanced
account of the conflict. It also needs to give diplomatic support to the LTTE to negotiate with the Sri Lanka government. If the international community wants peace in the area it must encourage this process.

So, Minister, please do not be fooled by the GOSL's recent claims of having dealt a terminal blow to the Tamils' 30 year plus quest for their own homeland of Tamil Eelam. It would be very short-sighted to view the GOSL's <u>capture of Kilinochchi</u> and the Elephant Pass as a major defeat for the Tigers; the truth is it is only a symbolic defeat, and certainly of immense propaganda value to the government. The real significance of these developments may convince the Tigers it's time to forget their mini-state and resume guerrilla war.

If this ends up as the GOSL's long-term military occupation of the Tamil homelands, surrounded by a sophisticated guerrilla force nurtured by the Tamil community, the implications would be ominous. The GOSL is keen to keep the delusion intact, particularly at a time when their army is bogged down in the Tamildominated war zone. The potentially catastrophic consequences for the GOSL are only too clear, even though they prefer to disregard the lessons of the massive military reverses they suffered just ten years previously.

What is needed now is for a major and concerted international political intervention, backed by an international peace keeping force. Your recent pronouncements have not assisted this process and your determined refusal, in spite of repeated entreaties by your fellow parliamentarians, to condemn the GOSL's use of cluster bombs against the innocent Tamil civilians is not a harbinger of good sense or impartiality.

Perhaps I could leave you with one final thought, as reported in yesterday's Guardian article by Jonathan Steele in which he quoted the following extract from Lasantha Wickrematunge's speech 'from beyond the grave': "A military occupation of the country's north and east will require the Tamil people to live eternally as second class citizens, deprived of all self respect. Do not imagine that you can placate them by showering 'development' and 'reconstruction' on them in the postwar era. The wounds of war will scar them forever, and you will have an even more bitter and hateful diaspora to contend with."

It's your call Minister. We are ready to oblige.
